NEW BOATING FACILITIES: PADDLING ENHANCEMENT GRANT PROGRAM

The Division of Parks and Watercraft is offering \$500,000 in grants to improve boating access for hand-powered watercraft at public facilities.

Applicants may request up to \$75,000 for a single project during the grant period.

The application is available at watercraft.ohiodnr.gov/grants and must be postmarked by March 1, 2020.



NEW BOATING FACILITIES: PADDLING ENHANCEMENT GRANT PROGRAM

The grant period runs from May 1, 2020, through Sept. 30, 2021. Applicants are encouraged to include one or more of the following criteria listed below:

- improving existing paddling access site and paddling safety;
- promoting or improving Ohio's designated or proposed water trails;
- meeting Americans with Disabilities Act guidelines;
- connecting paddlers to amenities, such as shopping, restaurants, and overnight accommodations; and
- using "shovel ready" projects.



OHIO WATER TRAILS PROGRAM

Two new trails in 2019: Cuyahoga River and the Lake Erie Islands

At least 2 additional dedications scheduled for 2020: Tuscarawas River – May 15th & Portage River – June 19th; working with communities on the Cleveland Lake Front and Blanchard River

LAW ENFORCEMENT AND SAFETY SERVICES: RECRUITMENT


- 7 new Natural Resources Officers joined the Division on February 3rd

PFD Type and Label Changes

New Life Jacket Labels Hitting the Market: What You Need To Know

- The Coast Guard issued a rule removing references to *Type* codes In regulations on the carriage and labeling of Coast Guard-approved personal flotation devices (PFDs).
- This means instead of "Type 1" or "Type 3" PFDs for example, the Federal Regulations refer to PFDs as either "Wearable" or Throwable".



ADULT UNIVERSAL

- Drowning hazard if not worn.

PFD Type and Label Changes

Components of the New Labeling Standards

- The top panel (outlined in green) has size and performance information
- Just below the descriptive text are icons to illustrate the intended use and the turning ability of the life jacket
- The next set of icons are used to inform the user that a device may not be appropriate for certain activities, such as water-skiing, towed sports or personal watercraft
- The section outlined in purple is the Certification and Approval Panel which will contain the USCG approval number
- The last panel (outlined in orange) is the maintenance panel
